Pledge of Allegiance was recited.

Approval of Agenda: Addition to Old Business, #5 Science floor Call for Bids and under New Business, #5 Discussion of HB 1251. Nagel motioned, Day second to approve agenda with additions. Motion passed.

Visitors were welcomed.

Consent Agenda: Thorpe motioned, Heimbuch seconded. Motion passed. The consent agenda includes December meeting minutes, bills and communications.

Superintendent Report: Heimbuch motioned, Nagel seconded to approve superintendent report. Motion passed.

Business Manager Report: Day motioned, Thorpe seconded to approve business manager report. Motion passed.

Policy:

GAAE Critical Race Theory. Nagel motioned, Heimbuch seconded to adopt policy GAAE on first reading as written, and that it be presented for adoption at the next regular board meeting. Roll call taken. Motion passed 5-0.

GAAC-BR Procedure for reviewing complaints about instructional/resource material. Meehl motioned, Nagel seconded moved to amend board regulation GAAC-BR as presented and to make it the official board regulation of the district. Roll call taken, motion passed 5-0.

Old Business:

2023-2024 School Calendar. Heimbuch motioned, Day seconded to approve the second reading of the 23-24 calendar. Motion passed.

2022-2023 Calendar. Day motioned, Thorpe seconded to approve the changes to current year calendar. Motion passed.

Bus Bids: Heimbuch motioned, Thorpe seconded to approve the purchase of new bus from I State Truck Center for the price of \$123,985.00 with delivery in late 2023 or early 2024. Motion passed.

Music Award Cabinet: Old Band uniforms were sold but not enough to match cost of cabinet. Mrs. German was notified and she will gather donations.

Science Floor: Michael J Burns is looking at advertising for bids on January 26, 2023 and February 2, 2023. There will be the bid for the science floor, and four alternate bids of north, south, east and west windows which we can accept or deny as cost prohibitive. Heimbuch motioned, Day seconded to approve call for bids on the science floor stabilization and window replacement. Roll call taken. Motion passed 5-0.

Staff Spotlight: Mrs. Roberts, Mrs. Steiner, Mrs. Warren, Mrs. Bopp and Mrs. Haafke presented their research on Habits of Mind.

NDDOT: Beth Dooley of the NDDOT presented the mill and overlay of the curb ramps on Highway 1 scheduled for summer 2023. NDDOT is requesting a temporary easement of property regarding the two curb ramps on OPS property. Day motioned, Heimbuch seconded to approve the temporary easement. Roll call taken. Motion passed 4-0 with Nagel being absent.

Resignation of Spanish Teacher, EL coordinator and Tech integrationist Leslie Dethlefsen at the end of the contract period. Thorpe motioned, Heimbuch seconded to approve resignation with deepest regrets. Motion passed. Nagel absent.

Negotiations Unit Recognition: Heimbuch motioned, Thorpe seconded to recognize the Oakes Education Association negotiations body. Motion passed. Nagel absent.

Business Manager Self Evaluation: Will do more complete evaluation this summer.

HB 1251: Heimbuch motioned, Day seconded to make it known that the Oakes Public School Board is in opposition of this bill. Roll call taken. Motion passed 4-0 with Nagel being absent. The Board instructed Superintendent Sell to draft a letter on behalf of the board.

Stop Light: This was added to the Good of the Order. HB 1246 is being heard on Thursday, January 19, 2023. This bill relates to the removal of the stop light located in Oakes.
