#### Student Achievement:

Choice Ready Student Experience: Brianna Schmitz gave a presentation on her work experience trip to Washington DC where she participated in the Senate Page Program.

Reading Program-Teacher Presentation (Moved up in agenda to accommodate teachers' schedules): Teachers Kelli Gebhardt and Becca Roberts gave a presentation on the new reading program called Super Kids K-2. This program goes along with the state mandated Science of Reading. They both stressed their approval of the program and believe it will make great strides in reaching the student goals.

Student Achievement Goals, Progress Monitoring, and Strategic Plan Update: The Goals adopted in Spring 2023 with the Be Legendary Training have been reviewed and adapted to current numbers. Rescind Policy GACA: Nagel motion to rescind policy GACA. This policy relates to correspondence courses. Day second. Motion passed.

Fastpitch Softball: Fastest growing sport in the state. Area schools are looking into adding this sport. Oakes Park and Rec are deciding on adding this sport as well.

SVL Coop: We have applied and been accepted as members of SVL. They are a government purchasing coop and they would be able to see what the price of a chiller would be. Seyer made a motion to rescind the motion approved at the August 31, 2023, special board meeting that read "The board will seek bids for a new chiller for the high school, size is to be determined with consultation with administration and Chiller Systems to determine size and specs". Heimbuch second. Motion passed.

Seyer moved that we join the TIPS public sector purchasing cooperative. Day Second. Motion passed.

Heimbuch move that we proceed with SVL to procure a quote for a new chiller through the TIPS cooperative if there are no additional costs associated if we decline the quote. Seyer second. Motion passed.

Annual Financial Report: Nagel moved to approve annual financial report. Heimbuch second. Motion Passed.
